- O1. Send a prescription through escribe, fax, or give us a call! Sweetgrass Pharmacy will call your patient to confirm their surgery date and delivery method. If the patient does not receive a call or text within 24 hours, please have them call 843-800-7007.
- Once verification is complete, Sweetgrass Pharmacy will take your patient's method of payment.
- Have your patients check their mail. Patient Rx ships free of charge the same day and delivers to patients in 1-2 days. Patients will receive a tracking confirmation and a tracking number via text.

## How it works:

- Autologous serum is obtained from the patient's blood. Once the blood is drawn, the red blood cells and clotting factors are removed, leaving only the patient's natural blood serum. This contains the same biological nutrients that are naturally found in the patient's tears. Because the serum is derived from the patient's blood, it is non-allergenic and natural to the eyes, unlike traditional eye drops.
- Our pharmacy dilutes the patient's personal blood serum with a sterile, preservative-free solution, providing a tear substitute that is unique to the patient's chemistry; therefore, there's no burning or stinging.

## What you need to do:

- O1 Issue (e-scribe) a prescription for the autologous serum eye drops (ASEDs) and for blood to be drawn.
- Once the prescriptions have been received, the pharmacy will contact the patient and coordinate a blood draw by one of our phlebotomists. The blood draw and serum processing are done all in the same convenient location.
- O3 The patient's eye drops will be ready the same day of the blood draw, if taken at Sweetgrass.

  The pharmacy will contact the patient when the eye drops are ready for pickup.
- O4 If necessary, blood draws can be shipped to the pharmacy. Completed eye drops can be shipped to the patient and delivered in 1-2 days.
